#### TERMS AND CONDITIONS OF THE TENDER:

#### 1. COMPLETION PERIOD

The completion period for the works is 36 months/ 3 Years from the date of issue of letter of intent.

### 2. EARNEST MONEY DEPOSIT (EMD)

- (a) All the tenders/bids must be accompanied by requisite Earnest Money in the form of a Demand Draft or payment through online mode.
- (b) Technical Bids of only those bidders who have submitted EMD of the requisite amount in the desired form shall be opened.
- (c) Public Sector undertaking fully owned by the Bihar Government/Central Government/other State Governments/MSME shall be exempted from depositing Earnest Money, provided that a certificate of Government Ownership/certificate of registration for MSME is submitted.
- (d) Unsuccessful Bidder's Earnest Money shall be refunded within 30 (Thirty) days of the award of Contract/issue of LOI to the successful bidder.
- (e) The successful bidder's earnest money will be refunded after receipt of full Performance Security and signing the contract.
- (f) The earnest money may be forfeited, if the successful bidder fails to sign the contract agreement within 30 (Thirty) days of issue of Letter of Intent.

#### 3. TENDER COST

The cost (Non-refundable) of tender documents is Rs. 10,000/- (Ten Thousand only) which is to be paid to Bihar State Hydroelectric Power Corporation Ltd., Patna through e-payment mode (i.e. NEFT/RTGS/Net banking, credit card/ debit card) only.

## 5. ELIGIBILITY CRITERIA FOR BIDDERS:

- a. The bidder must be registered under Indian company Act 1956 with all statutory provision like EPF, ESI, GST, Income Tax, Labour license, etc.
- b. The bidder must have experience of providing security services for at least 03 (three) years in any of the Government department/ Corporations/ Autonomous Institutions/ Public Sector Undertakings of the Government of India or State Government or any other organization either private or public
- c. The bidder must have annual average turnover of Rs. 60 (sixty) lakhs and above during the last 3 financial years (FY: 2021-22, 2022-23 & 2023-24).
- d. The bidder must have license under the Private Security Agency Regulation Act PASARA), 2005.
- e. Memorandum of Article and AoA need to be submitted (Mandatory).
- f. The agencies have to submit affidavit sworn before the Executive Magistrate that the bidder is not a blacklisted contractor/company by BHPC, Bihar Govt./ State Electricity Board/Power Distribution Company of State Governments or any organization of any State or Government of India (Format enclosed as annexure IV).
- g. The bidder have to submit 3,83,306/ (Rupees three lacs eighty three thousand three hundred six) as earnest money through online mode or DD in favor of BSHPC Ltd along with their Technical & Commercial offer in original/ hard copy. The tender without earnest money will not be considered.
- h. The agency must possess own communication facility/ patrolling vehicle etc.
- Consortium/ Joint Ventures shall not be allowed.

- j. In case of tie, selection of bidder awarded for work will be based on lottery system
- 1. The bidder shall submit his bid/tender on e-Procurement platform at www.eproc2.bihar.gov.in.
- 2. The bidder must have the Class II/III Digital Signature Certificate (DSC) with signing + Encryption, and User-id of the e-Procurement website before participating in the e-Tendering process. The bidder may use their DSC if they already have. They can also take DSC from any of the authorized agencies. For user-id they have to get registered themselves on e-procurement website <a href="www.eproc2.bihar.gov.in">www.eproc2.bihar.gov.in</a> and submit their bids online on the same. Offline bids shall not be entertained by the Tender Inviting Authority for the tenders published in e-procurement platform.
- 3. The bidders shall submit their eligibility and qualification details, Technical bid, Financial bid etc., in the online standard formats given in e-Procurement web site at the respective stage only. The bidders shall upload the scanned copies of all the relevant certificates, documents etc., in support of their eligibility criteria / technical bids and other certificate /documents in the e-Procurement web site. The bidder shall digitally sign on the supporting statements, documents, certificates, uploaded by him, owning responsibility for their correctness / authenticity. The bidder shall attach all the required documents for the specific tender after uploading the same during the bid submission as per the tender notice and bid document.
- 4. All the required documents should be attached at the proper place as mentioned in the e-forms otherwise the tender of the bidder will be rejected.
